## Winter Fuel Grants

- The total number of applications received for Winter Fuel Grants was 811 compared with 583 in 2016 – an increase of 39%
- Grant payments were made totalling £30,550.
- 75% of completed assessments qualified for a grant
- 60% of applicants had never applied for a winter fuel grant before
- 18% qualified for a grant under new Housing Benefit criteria
- Of the completed applications 200 were declined overall for the following reasons:
  - Out of criteria 85
  - No Contact from member 115

# Bereavement Support Payment

## Overview of the changes:

No age restriction now provided under state pension age and sufficient National Insurance paid and the lump sum if you have children is now £3500.00. (the new payment is disregarded by means-tested benefits and the benefit cap)

This replaces the 3-tier system of

- Bereavement Payment
- Bereavement Allowance and
- Widowed Parent's Allowance

The old Bereavement Allowance was only available to people aged over 45 at the time their spouse or civil partner died

- The new benefit is available to people of any age up to state pension age, and extends support from 12 to 18 months
- In addition, the new payment will now not be taxed, and will be subject to a disregard in the calculation of means-tested benefits and the benefit cap, helping those on the lowest incomes by providing extra cash at a time when it is need
- The new Bereavement Support Payment restores fairness to the system by being available to all people under state pension age whose spouse or civil partner made sufficient National Insurance contributions.
- The new Bereavement Support Payment is designed to help people with the additional and more immediate costs of the grieving period (instead of the notion of bereavement benefits replacing the deceased spouse or civil partner's earnings). This means a higher initial lump sum, and extending payments to 18 months to support them through a difficult time.

## The Bereavement Support Payment consists of:

- an initial lump sum of £3,500 for people with children and £2,500 for those without children
- a further 18 monthly instalments payable to the surviving spouse or civil partner of £350 for those with children and £100 for those without

The regulations for the new Bereavement Support Payment becomes available to people whose spouse or civil partner dies on or after 6 April 2017
